Rev. Mark Richardson




Rev. Mark Kevin Richardson was born and raised in Akron, Ohio. He is the son of Harrison and Josephine Richardson. He is a first-generation Church of God member, and minister, having grown up in the Catholic Church. He was educated in Akron through graduation from Archbishop Hoban High School. He attended Mount Union College, in Alliance, Ohio, graduating in 1979, with a Bachelor of Arts in Accounting, with a minor in Communications. Upon graduation, he worked for the IBM Corporation, from 1979 through 1983. While working in the computer industry from 1985 through 1996, Rev. Richardson developed as a lay minister under the pastoral leadership of Rev. Dr. Ronald J. Fowler in Akron. When his job required relocation to Maryland, from 1989 through 1991, he continued to develop as a lay minister under the pastoral leadership of Rev. Marc Farmer, of the Oakland Mills Church of God in Columbia, Maryland. Upon his relocation back to Akron in 1992, he resumed his development under

Rev. Fowler. Rev, Richardson was ordained in 1994, at the Arlington Church of God.

He came to a saving knowledge of Jesus Christ under the ministry of Rev. Dr. Ronald J. Fowler, of the Arlington Church of God, in Akron, Ohio, in 1981. He experienced the call on his life for Pastoral Ministry in late 1983, and began the process of preparation for ministry immediately. After a brief time of study at the Anderson University School of Theology, Rev. Mark returned to Akron to develop in ministry while returning to work in the computer industry for Digital Equipment Corporation.

In 1996 he answered the call to his first pastorate, the Lincoln Avenue Church of God in Pittsburgh, PA, where he was the Senior Pastor until July 2002. from 2002 until September 2019, Rev. Richardson served as the founding Senior Pastor of the New Life Church of God, in Pittsburgh, Pennsylvania, a thriving congregation reaching into Pittsburgh and its eastern suburbs. During his time in Western Pennsylvania, he served in the state ministry, as a member and chair of the Credentialing Services Team, and as Team Leader of the Church Health Team. Rev. Richardson also served as a member of the Ministries Council of Western Pennsylvania Ministries. For nearly two years from June 2012 through January 2014, Rev. Richardson served as a Co-Director of Leadership Development and Church Multiplication with Church of God Ministries in Anderson, Indiana, working for the General Director of Church of God Ministries. From October 2016 through August 2019, Rev. Richardson served as the Chair of the General Assembly of WPA Ministries of the Church of God and Chair of the Ministries Council. Beginning in September 2019, and continuing currently, Rev. Richardson is the State Pastor for the Church of God in Michigan. He currently serves as the Secretary of the Trustee Board of the Servant Solutions Pension Board of the Church of God. In addition, Rev. Richardson is a board member of the Church of God Foundation and Vice-Chair of the Regional Pastors Association of the Church of God.



The Credentials Team is deepening our understanding of our purpose and authority. Through clarifying our purpose, we are learning that credentials can be the way we love leaders and churches. The Credentials Team partners with leaders who are in the

credentials process. It is our honor to walk with candidates during their three-year journey through Leadership Focus.

We are charged with holding our leaders and churches to the high standards in our Credentials Manual. This can lead to challenging conversations and decisions. It also means that we celebrate with church plants and welcome churches who desire to join us in the Movement.

Your Credentials Team is comprised of leaders who evidence our state's wealth of wisdom, experience, and diversity. As Chair, I am privileged to work with Carl Baker (Secretary), Terry Bernard, Bob Confer, Chariese Matthews, Ron Nuckles, and Mark Richardson (State Pastor, non-voting exofficio member). Mike Harris resigned from the Team earlier this year as his new ministry assignment made it difficult for him to continue this work. We are all thankful for his time as Chair and for how he moved our work forward. You may not be aware that the State Pastor is not directly involved in the work of Credentials in many state ministries. I am thankful for the investment Mark Richardson makes in the lives of leaders in Michigan. I have witnessed him go over Theological Statements with candidates so they can fully understand their theology and calling. Mark is strengthening leaders who will impact our churches for decades to come.

The Credentials Ministry is recommending three individuals for ordination by our General Assembly this year. In addition, we have 26 individuals currently in the credentials process.

As we celebrate with those who are being ordained, let me encourage you to be praying for a harvest of leaders. The Credentials Team and I are convinced that we need to ordain 15 leaders a year to maintain the number of leaders needed in our churches and 25 to grow and plant churches where needed. This would lead to over 75 men and women in the ordination process.

I am asking each ordained pastor in Michigan to pray for ten leaders by name over the next three months whom they can encourage to enter the ordination process. Will you join me in this prayer?

If you have questions about the work of Credentials, don't hesitate to contact me. I know that the Credentials Manual and Leadership Focus can be overwhelming. We will work together to find clarity and a path forward.

The Credentials Team is humbled by the assignment given to us by the General Assembly. Thank you for entrusting us with this work.

Pastoral Health Ministry Report - Rev. Jeff Eckman, Chair



The Pastoral Health Ministry considers it a great privilege to walk alongside our pastors and their families to encourage and inspire them in the work that they do to help our Churches grow stronger and accomplish kingdom objectives.

We continue to plan and support the following events to promote the health and growth of our pastors:

- Ministers Retreat The Ministers Retreat is being planned for January 30-February 1 at Gull Lake Ministries conference center. Our theme this year will be "Still on the wall" from Nehemiah 2:17-18. Our speaker will be Handel Smith, Executive Director, US and Canada Strategies at Church of God Ministries - Anderson, Indiana, and Lead Pastor at Celebration Church at Arrow Heights. We will also have times of worship and fellowship together as well.
- Ministry Wives Retreat The Ministry Wives Retreat was held on September 16-18 at St. Francis Retreat Center. The speaker was Rev. Janell Robinson, and the theme was "Ministry Wives - Rooted in Christ" - Colossians 2:6-10. Worship was led by Jakisha D. Robinson and Mrs. Jen Foss.

These ongoing ministries still serve our pastors:

• Lifelong Learning Matching Funds - Churches can contribute \$150 (or more if they choose) per year for their pastors, and we match up to \$150. These funds can be used for training related to ministry, including the yearly Ministers Retreat. We have decided to add wording to our policy that will allow us to consider Ministers with a connection to the Church of God who are either between churches, or are pursuing ministry outside of the local church such as Chaplaincy to be able to contribute to this fund directly. Each application such as this will be considered on a case to case basis by the Pastoral Health Team as an exception to our base policy. As more of our ministers serve in non traditional ministries we believe that it is still important to support them in this way, as long as they strive to maintain a connection to the Church of God in Michigan.

- Ministry to Ministers The ability to get confidential counseling for our pastors and their families has made a huge impact in the health of our pastors and their families. This year, in addition to our traditional approach, we are adding, a partnership with Full Strength Network (fullstrength.org) which allows us to purchase licenses for our credentialed pastors and ministers, and a spouse or teens living within the home. It includes online access to fully accredited counselors and coaches in a fully confidential manner. We have purchased 10 licenses to get us started and will be evaluating the effectiveness of this resource to determine whether we will offer it in addition to our traditional counseling, or possibly instead of our traditional counseling going forward.
- Ministry Renewal Endowment Grants We have approved three grants, Each for \$1000.00. Two were to help cover additional education and training and one was to aid in a time of rest and recuperation.
- Clinical Pastoral Education (CPE) Programs -These programs offer training that is vital to Pastors seeking to do a better job Caring for people whatever they might be going through. Funds are available to those who apply and meet the criterion and are disbursed based on several criterion. Pick up a CPE Brochure from the state office for more information.

We have also had ongoing discussion about SHAPE type groups and the need for our pastors to be more connected with each other throughout the state. WE WOULD COVET YOUR SUGGESTIONS concerning what type of groups would compel you to participate, and what you might need from a monthly or bimonthly meeting of pastors, either in person, or via zoom. We recognize that the most successful groups of this nature tend to be organic and grow up out of relationships, but we would still like to do everything in our power to create an environment in which they can grow. PLEASE SEND US YOUR THOUGHTS AND SUGGESTIONS. The Lifetime Achievement Awards for this year will be awarded to Dick Latham, and Leo and Janell Robinson. The Outstanding Achievement Awards will be awarded to Rev. Dave Perry, Rev. Carl Baker, Rev. Jaime Cervantes.

We were concerned that more funds were being used for the insurance and upkeep on the cottage than were going to support the missions for which the group was founded.

After several meetings with our state board of women and the leadership of the campground at St. Louis we have decided to turn the Cottage over to the campground. They took over ownership on September 1, 2022. We came to an agreement that we will retain use of the cottage for three weeks in August each year, the week prior to camp meeting, the week of and the week following to ensure enough time to set up displays and pack things back away. Also that a designated storage area will be built within the Cottage for the safe keeping of historical records, scrap books and items donated to the CWC from our missionaries.

We also are concerned with the declining enrollment in the Christian Women's Connection. Membership numbers are down, and the Board of Directors has positions which have not been filled. We are currently in need of a President, Vice President, a Financial Director, and a Parliamentarian.






