since I came aboard. The role of State Pastor for this great assembly is both a privilege and an honor. I am thankful for you, your leaders, and your congregations. Credentials Ministry Report - Rev. Joshua Brandt, Chair



Do you remember the first time you met with your Credentials Team? Or can you recall when a pastor shared their nervousness as they prepared to meet about their Theological

Statements? Each year, leaders of all ages and experience walk into the Ministry Center or log on to Zoom for a meeting with the Credentials Team. They are often a little nervous and concerned that their work will fall short.

On the other side of the table is a team filled with hope. Leaders who believe the best about the candidate who is introducing themselves. Pastors who believe the best days of the Church of God are yet to come. I listen joyfully as questions are asked, testimonies are revealed, and the decision is made to license and ordain.

When the Credentials Team meets around the table, I am surrounded by 200 years of ministry experience. I am privileged to work with Terry Bernard, Bob Confer, Chariese Matthews, Ron Nuckles, JJ Perry, Emily Sparks, and Mark Richardson (State Pastor, non-voting ex-officio member). Carl Baker had a change to his schedule, which caused him to step away from the team. We miss his thorough minutes, gracefilled stories, and deep care for our candidates.

The Credentials Ministry is recommending four individuals for ordination by our General Assembly this year. In addition, we have 27 individuals currently in the credentials process.

In addition to our work with credentialing pastors, we work to ensure that the leaders and churches in Michigan are living up to their commitments. Sometimes, this means investigating to see if there needs to be reconciliation. Other times, we welcome independent churches into the Movement as they seek deeper affiliation and accountability.

We are also responsible for ensuring our pastors and churches maintain their connection to the Church of God in Michigan and the wider Movement. Recently, we learned that only 60% of our churches and pastors are registered. We understand there are many reasons for this. Please check your registration in Atlas as soon as possible. Registration is not the only way we keep connected, but it is an important step.

Pastoral Health Ministry Report - Rev. Jeff Eckman, Chair



The Pastoral Health Ministry considers it a great privilege to walk alongside our pastors and their families to encourage and inspire them in the work that they do to help our Churches grow stronger and accomplish kingdom objectives.

We continue to plan and support the following events to promote the health and growth of our pastors:

 Ministers Retreat – The ministers retreat is being planned for January 29-31 at Gull Lake Ministries conference center. Our theme this year will be *"Balance in Life and Ministry."* We will have five sessions, each covering an aspect of a Balanced Faith Walk, and each Session will be led by a different Pastor from, or connected to, our great state of Michigan. The sessions will be on Fellowship, Worship, Service, Study, and Prayer.

• Ministry Wives Retreat – The Ministry Wives Retreat was held on September 15-17 at St. Francis Retreat Center. The speaker was Rev. Veronica Roesly, and the theme was "Watchful Stewards of God's Grace." The Worship Leader was Minister Rachel Green, and there were 21 ladies in attendance.

These ongoing ministries still serve our pastors:

Lifelong Learning – Churches can contribute \$150 (or more if they choose) per year for their pastors, and we match up to \$150. These funds can be used for training related to ministry, including the yearly Ministers' Retreat. We also consider requests from Pastors who are in nontraditional ministries or in transition to apply to contribute to this fund directly. Each application such as this will be considered on a case-to-case basis by the Pastoral Health Team as an exception to our base policy. As more of our ministers serve in nontraditional ministries we believe that it is still important to support them in this way, as long as they strive to maintain a connection to the Church of God in Michigan.

- Ministry to Ministers The ability to get confidential counseling for our pastors and their families has made a huge impact in the health of our pastors and their families. Last year, we added a partnership with Full Strength Network (www.fullstrength.org) which allows us to purchase licenses for our credentialed pastors and ministers, and a spouse or teens living within the home. It includes online access to fully accredited counselors and coaches in a fully confidential manner.
- Ministry Renewal Endowment Grants We have not had any applications for these grants in the past year.
- Clinical Pastoral Education (CPE) Programs These programs offer training that is vital to Pastors seeking to do a better job Caring for people whatever they might be going through. Funds are available to those who apply and meet the criterion and are disbursed based on several criterion. Pick up a CPE Brochure from the state office for more information.

Rev. Dr. Carron Odokara will be facilitating the start of a "Pastoral Circles" opportunity to better connect pastors with each other. By gathering in small groups or "circles," we can build a ministry community to engage with one another across congregations. These groups will focus on prayer, encouragement and the sharing of thoughts and ideas. Circles will be designed to meet monthly for a year by primarily online meetings (unless a group happens to have people close enough to meet in person). Circles are self-guided by the group with a facilitator recruited through an online questionnaire to help with gathering the group. We are very excited about this new endeavor and hope that it will provide much needed friendships and partnerships between pastors and churches.

We have also decided to add funds into our budget this year to promote marriage retreats for pastors, utilizing the Focus on the Family retreats (Which Rev. Mike Harris works with), and possibly other formats in the future as well. We will try and target two-three couples in the coming year.

The Lifetime Achievement Awards for this year will be awarded to Mary Hirakis, and Shelton and Chariese Matthews. The Outstanding Achievement Awards will be awarded to Rev. Julie Wiseman, Rev. Dr. Julián Guzmán and Iglesia Vida Plena, and Rev. Dale Turner.

Youth Ministry Report - Rev. Emily Potter, Youth Ministry Team Leader



As we reflect on 2023 as a Board, we have seen periods of adjustment and recalibration. Change is never easy, but the partnership of those who care about our state's youth has been strong, even in the midst. Several members have moved from

our area, leaving gaps that others stepped in to fill. God has continued to call those with a heart for our young people to invest their time, effort, and imagination into what will be the future of ministry in Michigan. As we read in Isaiah 43:19, "See, I am doing a new thing! Now it springs up, do you not perceive it?" May we be open to where God leads!

We are extremely thankful for the investment Connie Graham has made in the work for the youth of our state, and while we are sad to see her retire from the position as Youth Administrator, we are excited for her to be able to enjoy more time with her family. She will continue to volunteer with the Winter Retreat Task Force through 2024. There are no words that can adequately express the gratitude we have for Connie's persistence, determination, and love for Michigan's youth.

Over the years, we have offered many opportunities for youth and their leaders to attend events throughout the state. Unfortunately, due to multiple challenges and dwindling participation at some of those events, we have discerned that we must relinquish some programs to bring fruit from those that remain. To implement these changes, we will not host a

State Youth Convention every year, starting in 2024. Due to IYC's alternating years, as well as the NIYC's schedules, we want to eliminate groups having to choose between which events to support. One of the most challenging aspects of this evaluation period is realizing that if a youth group wanted to attend all the events offered by both state and national youth programs, it would mean that not only would the groups be constantly fundraising, but they would be attending five events over seven months. This is overwhelming, especially considering that many of our churches do not have full-time youth pastors—many are parttime or volunteers. Add in the costs, manpower, and travel to and from these events, and both leaders and youth are overcommitted.

Michigan Student Leadership Institute (MSLI) has gained some steam, with participation increasing. Ben Kreider continues to lead this event, and Pastor Mark Staton and New Creation Church have graciously opened their church facilities to host it for years to come. I am



encouraged by the investment and mentorship that continues to grow from this program, which is one previously considered to be nearing its end of life. If God's not done, He's not done!

In conclusion, I must express my deep appreciation for those who give of themselves to ensure that our youth are being reached for Christ. Whether that be helping consolidate our current offerings to youth and their leaders, breathing new life into programs, the prayer warriors who spend time in their prayer closets on behalf of our youth, or developing concrete resources to better equip parents, leaders, and teens, thank you. Your investment has a generational impact and will last long after we are gone.

Twenty-Five+ Years Serving in Michigan

Pastor Andy and his family immigrated to the USA from Germany in May of 1997 to pastor the Washington Ave. Church of God in St. Joseph, Michigan. It wasn't the first time the Hannich family moved thousands of miles.

Let me explain: Remember the Jesus people in 60ties and 70ties. Their movement and songs caught the attention of some young people in Germany and Easter 1976 Andy became a Christian and began following Jesus. A group of teenagers in Andy's hometown of Marburg began organizing regular meetings, prayer breakfasts, and many came to know Jesus.

After high school, Andy felt led to study at the Bible School of the Church of God in Fritzlar. Germany for four years. There a Canadian math teacher, Ingrid, caught his eye, and she became the love of his life.

He moved to Canada, got married (1981) and ministered in Edmonton, Alberta. The German Church of God in Flourtown, Pennsylvania in the suburbs of Philadelphia gave them a call and they moved over 2,000 miles east. In the city of brotherly love sons Jeremy and Michael were added to the Hannich gang.

After five years, the church in Edmonton called them back because they needed help with the younger generation transitioning from a bilingual 'German' church to a 'community' church.

After eight intense years of battling the culture wars with Pastor Fritz Lenk on his side, it was time to take a sabbatical and move again thousands of miles to give the rest of his family a taste of Germany. During their time in Canada, Andy finished his Bachelor of Arts and Ministry at Gardener Bible College, and God added Jonathan (Jo = God + Nathan = gift) to the family.

In Germany Andy joined his parents in running a nursing home located beside the castle back in Marburg where he was born. His oldest son even had a teacher that had also taught his dad. Andy took advantage of the

practically free enrollment as a student of theology and studied Hebrew, Greek, and Philosophy at the University of Marburg. The family enjoyed traveling all over Europe, giving their sons a chance to experience a different culture with lots of castles, history, soccer, and the occasional Wiener Schnitzel.

While eating dinner in the cafeteria of the nursing home, they received a beautiful bouquet of flowers with a ticket to Chicago from the Washington Avenue Church of God. Wow! After three years of trying to adjust to the German culture, the Hannich family was ready to speak, eat, and breathe the American way of life again.

Packing everything up again and moving back over 3,000 miles was a logistical nightmare. But with the help of congressman Fred Upton and a persistent church, we legally immigrated to the USA. You may understand that our sons kindly requested to stay in St. Joseph for a while, at least until they finished high school. That was 26 years ago. It didn't take long for the Hannich family to fall in love with the church, the area, and the people of Southwest Michigan.

As you may have guessed, Andy and Ingrid enjoy traveling (they have visited over 50 countries), hanging out with their family including eight grandchildren, walking along the bluff in St. Joseph, and most of all our risen Lord, Jesus Christ.
