

General Assembly of the Church of God in Michigan Statement of Membership

- A. The pastor of each congregation within the state of Michigan.
- B. The members of all the recognized ministries and committees of this organization.
- C. The associate pastors/ministers called by each congregation on a full-time or part-time basis.
- D. One layperson chosen as an official representative by each Michigan Church of God congregation with an average weekly attendance to 100; two laypersons from each congregation with an average weekly attendance

- of 101–500; three laypersons from each congregation with an average weekly attendance of 501–1000; and four laypersons from each congregation with an average weekly attendance of 1,001 and above.
- E. All others who are registered in the current Yearbook of the Church of God or have served as past chairs of the Michigan General Assembly, and who reside in Michigan and worship in Church of God congregations in Michigan.
- F. One delegate as appointed by each recognized Camp Meeting Association within the state.

Annual Business Meeting Session 1; November 10-11, 2023

9:00 a.m. Welcome: State Pastor Mark Richardson, opened the 103rd General Assembly.

Worship: Sarah Scharbrough McLaughlin and team led the assembly in worship.

Message: State Pastor Mark Richardson delivered the message from Hebrews 12:1-4 from the New Living Testament, "Running the Race with Patience and Persistence."

Worship: Sarah Scharbrough and team.

Benediction: State Pastor Mark Richardson.

- 10:45 a.m. Pastor's wives tea with Rev. Flynn and Pastor's Husband coffee with Rev. Sheppard.
- 10:50 a.m. The Vice Chair Charles Nebus, Covering for the Chair Tad Mellish, called the first session/meeting to

- 10:51 a.m. Vice Chair prayed over the meeting and events.
- 10:52 a.m. The vice Chair, presented the agenda and program booklet for all the activities and reports found in the booklet for 2023 Annual Meeting.
- 10:53am The vice Chair read the vision and mission statements found on the back page of our booklet. The vice Chair also gave special thanks to Jeannette Flynn, and Dr. Horace Sheppard Jr. to Sarah Scharbrough and her family, to Jake Seaton and his team in the sound, and to Becky and Goldie in the State office.
- 10:56 a.m. The vice Chair presented to the membership the New Pastorates and Associates found on page 7 & 8 of our booklet with recognition.
- 10:57 a.m. The vice Chair read the statement of voting membership found on page 4 of the booklet, according to Article IV of the by-laws, and that a quorum was present and achieved.

The vice chair brought attention to the previous minutes, and the minutes from pages 9-13 of the 102nd General Assembly were accounted for, accepted and certified.

10:58 a.m. The vice Chair, called the State Pastor Mark Richardson to the podium.

Mark Richardson gave special thanks to the following people:

- Steve Starks Pastor of the First Church of God in South Haven for the work on teaching about End Times.
- 11:05 a.m. State Pastor Mark Richardson shared 4 things to accomplish and celebrate for 2024 and beyond;
 - That we have a diverse contingency, and yet there is still a real need to plant a church in the upper north region.
 - The Church of God in Michigan has a rich history.
 - This is the 103rd General Assembly in Michigan and going strong.
 - In 2024 we will celebrate 100 years of youth ministry for the state.

Also Mark shared that in 2022 that we had to close a church, and this was a tough lesson.

The Church of God had at one time 2200 churches and now we have roughly 1900 congregations, so the number is reducing.

Mark Shared that part of the joy is celebrating with churches like Crystal Springs Church of God in Benton Harbor and their 100 year Anniversary celebration. Mark apologized for missing the recent Hymn Sing Celebration yet, we have much to celebrate.

Mark shared about the return on investment and his prayer is that we as a body with intentionally and passionately exalt Jesus Christ as Lord and Savior.

- 11:12 a.m. State Pastor Mark Richardson reviewed his State Pastor's Report found on page 14 & 15 with a look back at 2023.
 - Mark shared that he is still working on his health and time management, which he is doing better, but still is a work in progress and he is thankful for all the prayers.
 - On Sept 16th they celebrated one year with Rev. Mark and Heather Robb and the connect church.
 - Celebrated the Sanford Cultivate Coffee shop and Eagle Ridge Church.
 - Mark also shared another success in the Eau Claire Satellite Church along with the Bethlehem Temple Church.
 - The Anchor Church in Berrien County with their Community work. Building a separate building to house supplies and over 1000 people served in their community over the last two quarters.
 - A testament to the wonderful things happening in the State.
 - Mark Shared that we have six new Pastors in the State, where we originally had 12 open positions for pastors, we now have 3 open slots.
 - Mark shared information regarding the Winter Youth Retreat.
 - The 360 conference was a success with nearly 400 people attending.
 - Mark shared about the Academy of Servant leadership with the first session featuring- Karl Vaters and the second session featuring Bob Moss.
 - Mark shared that the MSLI will be at New Creation Church in March of 2024
 - Mark also talked about the many connections events and the excitement available to all.

State Pastor Mark, bridged into sharing about the Midwest Multiplication Initiative, which is a joint initiative between Ohio, Michigan, Illinois, Indiana.

Mark shared about the 120 people involved in the support of the MMI, who participated in the Mission 120, with 26 of those in Michigan.

Mark turned our attention to the Launch 32- and the excitement surrounding the 32 new expressions of the church in all four states over the next five years. We have already launched two this year.

Mark talked about the Midwest Hispanic Church Planting Initiative between Michigan, Indiana, Ohio, Illinois, and Western PA- and the work of the Gomez family as consultants working with the five states to plant Hispanic Congregations.

Mark focused on how 15 couples from 5 states with 4 in Michigan are part of the Midwest Hispanic Planting Initiative, and how the Orchard View Church of God in Grand Rapids has made space available for a Hispanic Church Plant in 2024.

Mark talked about the planting of a church in Flint also, as West Court Street Church of God has agreed to host a Hispanic congregation in the future.

Mark then shared the excitement over 4 people ready for ordination who will be presented to the assembly later in the meeting.

11:25 a.m. Mark turned our attention to the 2024 vision for the State Offices, where there is a specific need for a part time office staff to assist in the ongoing work, and his vision for an Associate State Pastor. The specific needs are designed to keep the functions of the State office running without everything left in the hands of one person, and then the Associate State Pastor to help Mark extend the reach of the State office to congregations across the state.

Mark shared about the Academy of Servant Leadership and upcoming Zoom meeting on February 3, and the May and Sept. meetings would be in person.

Mark shared about the 7 Theological Statements which Joshua Brandt would elaborate about later, with the working particulars.

Mark share about some of the resources to the Ministers; including the Mental Health and Counseling through the Ministry to Ministers program which the State office would cover the \$120.00 co-pay of the sessions, up to 12 sessions. Mark also shared about the Full Strength Network with coaches and counselors.

Mark shared about the opportunities to develop and train coaches for the Pastors and the State office is looking for those who would desire to get involved.

Mark shared about Mission Insight, where for the Church of God in Michigan investing \$500.00 all of our churches can utilize the demographic studies to help target and develop missions and ministry with a specific focused core group.

Mark shared about Retreats, including those for Women, MALU, and the Wesleyan Retreats.

Mark turned his attention to the Ministry for the Youth.

- No State Youth Convention next fall.
- There will still be the IYC and NIYC.
- The team is working on restructure and providing resources, instead of just having retreats, where the emphasis has been too many in one year.
- The idea is to develop Youth and a focus on the developing potential new Pastors for those sensing the call into ministry.
- The state is looking for Youth and what is the plan to develop the future leaders.
- Trellis is a development plan or program for the youth to answer the call to ministry.
- Mark also shared about Financial Literacy-Outreach Ministry to the churches in the State and that we are still seeking funding for this program.

11:40 a.m. Mark talked more about the staffing needs and the visual graphics to share with the state assembly, of the

current status, the 2024 status, and the future state. The visual graphics provided details on the breakdown of job duties along with functions and roles with each position.

- 11:44 a.m. Budget and Finance Reports

 Mark shared the budget report found on page 16 and following of our Booklets.
 - Mt. Pleasant church land contract sale finally closed.
 - We are currently \$400.000.00 above the budget
 - Some of the expenditures included supplemented the many events throughout the year.
 - Final results will come later, but we are on track to be under budget.
 - The roof work on the state office came in \$20K under budget.
 - The parking lot work was only \$8K and is working okay so far.
 - 2024 the plans are to replace the glass works on the offices to make a more secure entryway.
 - Nothing stands out at this point.
 - The new positions such as the State Associate Pastor will generate expenses due to technology cost and supplies.
 - Please review the rest of the budget provided in the booklet and let Mark know of any questions or concerns that you might have.
 - 11:51 a.m. Mark turned the meeting back over the Vice Chair Charles Nebus.
- 11:52 a.m. Vice Chair Charles Nebus introduced two videos from Cleveland Howell III, and Rachel Green, both candidates for ordination from page 25.
- 12:00 p.m. Charles Nebus gave a special thanks to those completing terms of service found on page 28 with a round of applause.
- 12:01 p.m. Charles Nebus introduced the videos for Jesse Hargett and Alexander Young from page 25 the final two ministers for ordination.
- 12:07 p.m. Charles Nebus acknowledged all the candidates.

12:08 p.m. Charles Nebus turned the meeting over the Rev. Mike Potter the Chair of the Business Committee.

Mike Potter shared the presentation of the Ballots passed out to the General Assembly. Mike asked the voting members of the General Assembly to please mark their ballots and turned them into the tellers for counting. It was noted that prior to the General Assembly Meeting some of the ballots were prepared via electronically. If anyone has reservations please mark the ballots accordingly and with reasons.

Mike Potter turned the meeting back over to Charles Nebus the Vice Chair.

- 8:49 a.m. Rev. Jerry Lyon shared information about the National Discipleship forum and there will be more information to come about the forum.

 Charles Nebus introduced Mike Potter the Business Committee Chair.
- 8:51 a.m. Rev. Mike Potter shared about the budget ballot and asks the General Assembly to please mark your ballots, folding once and turn them into the tellers.

Church Health

The conversations at Academy of Servant Leaders (ASL) about bylaws and policies created "on-ramps" for church health conversations. Often, I am invited to discuss Bylaws and policies, but we end up discussing the health of the church and the next steps towards reaching their community with the good news about Jesus. Please contact me if your church wants to review bylaws and policies.

- NewThing/Exponential. In May, we partnered with NewThing, a part of Exponential. I am learning what they call the
 "Movement System." The plan is to see when and where this can help churches in Michigan network together on
 mission. I meet twice a month for training and conversation. Our first pilot network will launch in the next few weeks.
- **360 Ministry Conference.** The 360 Conference is scheduled for Saturday, March 15. We will share more details and ask for your input during General Assembly.

Credentials

The work of credentials is vital to our church health, leadership development, and multiplication efforts. This team is responsible for the recognition and credentialing of pastors and churches. The credentials team meets at least nine times a year. Each agenda is full and allows the opportunity to speak into the lives of leaders. We are doing good work with our candidates and churches. We also are committed to doing even better.

- JJ Perry. Over the last several months, we have transitioned the credentials chair to JJ Perry. JJ has experience with leading a credentials team in Indiana. He is committed to our candidates, churches, and the importance of credentials. I am thankful that this trusted leader has agreed to take this on.
- Melissa Daniel. Melissa agreed to take my seat on credentials. She will finish the term I vacated. Melissa brings a
 wealth of ministry experience to the team. She also served with credentials in Western Pennsylvania. Her joy, wisdom,
 and compassion are evidenced in our meetings.
- Thank you to Bob Confer and Terry Bernard, who are both finishing two terms with credentials! Their walk with Jesus, wisdom, and care for our candidates was evident in every meeting.

Youth

Our youth team has not met regularly this year. When we met, concerns were expressed about how many of our events have become disjointed and siloed. While several of our churches are seeing a resurgence in youth ministry, few have dedicated youth pastors. Our youth ministry team and event planning were designed when many churches had youth pastors and several youth groups across the state were large.

In 2025, we plan to reorganize the team to meet current youth ministry needs across the state. In addition, our youth ministry events will align with our renewed mission and vision for state ministry. I will work closely with our event teams (Winter Retreat, MSLI, 360, etc.) to develop a multi-year plan with a unified focus, dates, and speakers.

- Youth Winter Retreat. Winter Retreat (January 3-5) is being planned by Adam Rentas, Trevor Moody, and Jesse
 Hargett. This team is entrusted with planning, promoting, and evaluating the Winter Retreat.
- Michigan Student Leadership Institue (MSLI). MSLI is scheduled for February 28-March 1. Ben Kreider and his
 team are working to ensure that MSLI aligns with the student leadership initiatives across the state.
- Intern Academy, Trellis, etc. I am developing relationships with the leaders of programs designed to equip the next
 generation of pastors and leaders. These initiatives across the Church of God are seeking to partner with young
 leaders as they explore their call.

Pastoral Health Ministry Report - Rev. Jeff Eckman, Chair



The Pastoral Health Ministry considers it a great privilege to walk alongside our pastors and their families to encourage and inspire them in the work that they do to help our Churches grow stronger and accomplish kingdom objectives.

We continue to plan and support the following events to promote the health and growth of our pastors:

- Ministers Retreat The Ministers Retreat is being planned for January 27-29 at Gull Lake Ministries conference center. Our theme this year will be "The Resilient Pastor". John Opalewski of Converge Coaching will be our speaker, and Kim Salyer of Farmington Hills will lead worship.
- Ministry Women's Retreat The Ministry Women's Retreat was held on September 13-15 at St. Francis Retreat Center. Jessica Cyriaque-Staton from New Creation Church of God was the

Speaker and Sister Kim Salyer from Farmington Hills Church of God, Led the Worship, and the theme was "Expand."

These ongoing ministries still serve our pastors:

- Lifelong Learning Churches can contribute \$150 (or more if they choose) per year for their pastors, and we match up to \$150. These funds can be used for training related to ministry, including the yearly Ministers Retreat. We also consider requests from Pastors who are in nontraditional ministries or in transition to apply to contribute to this fund directly. Each application such as this will be considered on a case-to-case basis by the Pastoral Health Team as an exception to our base policy. As more of our ministers serve in nontraditional ministries, we believe that it is still important to support them in this way, as long as they strive to maintain a connection to the Church of God in Michigan.
- Ministry to Ministers The ability to get confidential counselling for our pastors and their families has made a huge impact in the health of our pastors and their families. Two years ago, we added a partnership with Full Strength Network but sadly this network folded due to the difficulty of finding Counselors. We do, however, still offer the traditional support through counseling as we have in years past.
- Ministry Renewal Endowment We approved two applications for grants in the past year.
- Clinical Pastoral Education (CPE) Programs These programs offer training that is vital to Pastors seeking to do a better job caring for people whatever they might be going through. Funds are available to those who apply and meet the criterion and are disbursed based on several criterion. Pick up a CPE Brochure from the state office for more information.
- The Pastoral Circles kicked off this year, and it is our hope that many meaningful relationships and connections will be made to support the pastors who chose to be a part.
- Marriage Retreats are now being offered by Focus on the Family free of charge for our pastors and their spouses. Pastor Mike Harris has been instrumental in making this connection for us and can provide more information on these retreats.

The Lifetime Achievement Awards for this year will be awarded to Brian Hansen and Tim Foreman. The Outstanding Achievement Awards will be awarded to Steve Gulick and Albert Grant.






